The asset is located at a signalized intersection at West Bay Drive and Indian Rocks Road. More than 31,500 vehicles pass this location daily (AADT), with an average household income of \$93,120 within a 3-mile radius of the property.

Walgreens has been at the site for twenty (20) years and currently has over 5 years of term left with single cancellation options starting on 8/31/2028 that renew every 5 years. The property offers an investor the opportunity to acquire a fully occupied property with stable cash flow and zero landlord responsibilities.
